

TxIDTF Prevention Subcommittee Meeting

Meeting Notes | May 22, 2023 @ 1:00pm

Purpose of the meeting: To re-establish a new working group, vision, and goals for this subcommittee within the new structure of the Task Force.

1. Prevention Letter

2. Subcommittee Goals

- Goal 1: Identify and invite key stakeholders in prevention that would benefit from involvement or incorporation to task force activities
- Goal 2: Review and discuss relevant traffic safety documents related to the Task Force as needed (impaired driving plan, SHSP, NHTSA recommendations)
- Goal 3: Keep up to date with the state of the practice, trends, and local issues that impact prevention issues
- Goal 4: Share lessons learned, recommendations, and strategies to enhance prevention efforts across the state

3. Recruitment Strategies

- SRO Assessment Recommendation: Promote and support placement of school resource officers (SROs) in schools throughout Texas.

4. Needs from the Task Force

- Help disseminate information, specifically TxDOT impaired driving communications
- Help establish partnerships with professional organizations/associations and corporations
- Help identify relevant stakeholders to disseminate information/resources to and to get information/resources from
- 5. Other Issues/Concerns/Thoughts

- Issue 1: Polysubstance use roadblocks
 - Polysubstance use is identified as a community issue but difficult to get funding to address it, given many of Texas' policies and attitudes towards illicit substances
 - Where can we look for data on the issue? Where can we look to for a better understanding of polysubstance use?

- Issue 2: Duplicating outreach efforts
 - There may be some duplication of outreach efforts with the implementation of the TxDOT strategic plan. TxDOT subgrantees must contact all jurisdictions with certain crash criteria. There could be a lot of overlap and overwhelming for stakeholders being contacted.
 - Are we contacting the same people? Why are we not getting results from contacting these jurisdictions?
 - There is an opportunity to cross collaborate. For example, if a school is requesting a presentation on a day that is unavailable for the program, they can refer another prevention program with similar goals.
 - Work together to identify gaps and strengths in programs and combine resources. Example, one program may be on a community level but could use some help from another program working on a peer-to-peer level.
