- TxDOT Update
 - Completed RFP in January 2024. There were 288 proposals (including STEP).
 - Scoring process has been completed. Now reviewing the scores and determining funding.
- FARS Data / Revised CR-3
 - Jim presented at the Texas Impaired Driving Forum on the pending changes to the CR-3
 - He received good feedback form officers in attendance.
 - A field for "expect alcohol involved? Yes or No" will be added for all KA crashes (also will add for drugs)
 - Will help close the gap between the FARS numbers and CRIS numbers (e.g., in 2021 – FARS reported over 1900 BAC>0.08 fatal crashes in Texas and CRIS reported just over 800 BAC>0.08 fatal crashes
 - Discrepancy comes from NHTSA estimating BAC>0.08 for all fatal crashes without a reported BAC/alcohol involved. Adding the field for "Expect alcohol involved? Yes or No" will help reduce some of the crashes the estimation applies to
 - Also adding "Expect drugs involved? Yes or No"
 - TxIDTF members requested a check box for polydrug use be added in the CR-3 revisions

- Retailer Enforcement and Education
 - TABC is starting their underage drinking initiatives with spring break coming up

 - Consumer Delivery/Alcohol To Go
 - During the COVID Pandemic the Governor issued Executive Orders that relaxed the control of how alcoholic beverages were sold.
 - After the pandemic, the 87th Texas Legislature codified this into law to allow bars and restaurants to continue delivering and selling A/B to go with stipulations.
 - Eligibility of Certain Retailers: Mixed Beverage and Private Clubs:
 - Must holder a Food and Beverage Certificate
 - Must be sold with a bonafide order of food.
 - Alcohol must be in the original container sealed by the manufacturer or in a tamper-proof container by the retailer.
 - For consumption off the premises
 - May also make deliveries
 - Eligibility of Certain Retailers: Consumer Delivery Permit (CD)
 - The CD permittee may make deliveries of alcoholic beverages only in response to bona fide orders placed by the consumer. The holder may employ or contract with a driver to deliver alcoholic beverages from an authorized retailer's premises to an ultimate consumer located in an area that is legal/wet for the type of beverage being delivered. The beverage being delivered must be sold to the consumer by specifically authorized retailers that hold a license or permit including off-premise locations.

- Any person delivering alcohol under this authority must **be at least 21 years old** and hold a valid driver's license.
- Requirements for Completing a Delivery: The same standards for selling/serving alcohol to consumers on a retailer's premises apply to delivering alcohol to consumers located off the retailer's premises. It is illegal to deliver an alcoholic beverage to a minor or an intoxicated person. Additionally, it requires the recipient of the alcohol to present the driver with valid proof of their identity and age before the alcohol is handed over to the recipient.
- Few complaints have been filed about Alcohol To-Go/Consumer Delivery but TABC started doing compliance checks in the Summer of 2023.
 - To determine the level of compliance regarding Consumer Delivery (CD) Permits and licensed locations offering alcohol to-go.
 - Field Operations along with Audit and Investigations (A&I) conducted operations over a two-month period.
 - Field Operations focused on public safety violations and A&I on regulatory violations.
 - Consumer Delivery Violations (98 attempts) complicated operation (requires hotel rooms, numerous undercover minors, logistically difficult and time consuming)
 - 10-Making A/B Available to a Minor (Criminal Only)
 - 1-Improper Packaging (Admin Only)
 - To-Go Violations (101 attempts) minor operation, did not order online (orders placed in-person)
 - o 29-Sale to Minor (Adm/Crim)
 - 21-Improper Packaging (Adm Only)
 - 4-Permit Removal (Adm Only)
 - 1-Sold without Food (Adm Only)
 - 2-No FB (Adm Only)
- Question: Would law enforcement arrest a delivery driver with an open container? Would prosecutors pursue charges? Issue with intent of the driver. Businesses are protected from criminal charges.
- Impaired Driving Enforcement Training and Detection Carlos Champion
 - On track to meet all FY 2024 training expectations for SFST, DRE, ARIDE
 - 369 DREs
 - 43 DRE Instructors
 - 121 DRE Agencies
 - 561 Enforcement Evaluations in 2023
 - \circ $\;$ Issue identified with nonuniform SFST training across the State.
 - SFST is the base to DRE and ARIDE. Officers must perform a SFST proficiency test in DRE/ARIDE classes but is has become clear that officers are completing the tests differently depending on how they were trained. This is an issue since

SFST should be standardized and based on the manual.

- To help alleviate some of the discrepancies, TMPA has developed sample scripts for officers on how to administer SFST. However, more standardization needs to occur.
- SFST in Texas
 - SFST training used to be under just one agency. However, about 20 year ago, anyone who became a certified SFST instructor can deliver the course. There is no oversight for these instructor courses.
 - There are some SFST instructors (who charge class fees) that are not following the SFST manual and therefore training officers incorrectly. This hurts the validity of the SFST and credibility in court when an officer does not do the proper steps in the manual.
 - TxIDTF Executive Committee Member recommends to bring control and management of all SFST courses to TMPA in an effort to standardize the test.

1:00 PM Breakout Groups: 2024 Texas Impaired Driving Plan

- The TxIDTF discussed several recommendations as a group. Including:
 - Program Management:
 - Leverage the executive authority of the Texas Impaired Driving Task Force to provide the Governor and key members of the state's Senate and House of Representatives with an inperson account of the group's work along with an educational report on the status of impaired driving-related crashes to include associated data and research regarding the carnage of human lives lost and associated costs.
 - While most members cannot lobby, we do have the ability to educate lawmakers as a task force.
 - Member groups who can lobby include: MADD, NSC, MoCo DAO, TDCAA
 - 2. Expand the composition of the Impaired Driving Task Force to fill representation gaps created by the lack of experts in the fields of local public health, emergency medicine, and alcohol and other drug treatment and prevention programs. Other groups to be considered for membership should include representatives from the military, veterans, employers, and community groups, especially those representing diverse populations.
 - Invite to working groups or on an add needed basis to get them involved: military/veterans, treatment, emergency medicine. May not need to attend every task force meeting if it is not relevant to them.
 - Emma Dugas to reach out to responsibility.org for

military/veteran contact in Texas. Nancy Winn to reach out to drug treatment court contacts.

- 3. Develop partnerships with major corporations, or their representative professional associations, to expand the reach of the impaired driving program and potential funding and/or incentive opportunities.
- Prevention:
 - 1. Promote and support placement of school resource officers (SROs) in schools throughout Texas.
 - Prevention Subcommittee to address school representative.
- Enforcement:
 - 1. Support the expansion of Law Enforcement Advanced Data Reporting System (LEADRS).
 - The Executive Committee signed a letter of support to utilize LEADRS as a foundational component for a statewide DWI tracking system. Is there anything else the TxIDTF can do to support this recommendation? Not at this time - the letter is in the hands of TxDOT leadership.
 - 2. Encourage the Texas Chiefs of Police Association and the Sheriffs' Association of Texas to develop traffic safety committees.
 - Kevin Harris to reach out to Chiefs of Police Association contacts.
- Prosecution:
 - 1. Write a white paper setting out the requirements and rationale for a complete *driving while intoxicated tracking system*.
 - 2. Obtain technical assistance to determine if and how the prosecutor case management systems currently in use can share data and what other agencies might be included in the sharing.
 - Clay working on questionnaire to survey prosecutor offices on the requirements and rationale for a DWI tracking system. Expected to be completed in FY2025.
- Adjudication:
 - 1. Work with Law Enforcement Advanced Data Reporting System (LEADRS) and other justice information systems to design a path forward to have a *driving while intoxicated tracking system*.
 - 2. Invite the tribal court judges and staff to attend the Texas DWI training.
 - TxIDTF members to reach out to tribal contacts. Clay has invited tribes to prosecutor trainings. David has been requested to provide SFST training to the Kickapoo tribe (issue with funding)
- Alcohol and Other Drug Misuse
 - 1. Identify, train, and support qualified assessment and evaluation professionals in underserved areas.
 - 2. Conduct an impact evaluation of driving while intoxicated courts.

- The Governor's Specialty Court Advisory Council will be conducting an evaluation of two DWI Courts in 2024: Dallas County Misdemeanor DWI Court, Dallas County Felony DWI Court
- TxIDTF members then broke out into stakeholder groups to discuss the Plan more thoroughly. All revisions are due to Christine by March 15.
